A proposal for a Bill to improve animal welfare by enhancing local authority pet shop licensing powers and updating the licensing system, including in relation to licence conditions, fees and inspections. As responsible pet retailers we feel that a clearer unified approach to pet shop licensing across multiple council areas is a good thing. Our stores in England are part of OATA's Primary Authority Scheme which was introduced in partnership with the City of London Corporation resulting in an improvement in the quality and reach of inspections. Importantly any legislation must be sensible and proportional rather than introducing too much red tape.

Licensing fees vary wildly across Scottish councils with seemingly no relevance to cost of inspections or services provided. The most expensive licences seem to have the least contact with our stores. A standardised and reasonable cost across all council areas would also reflect hopefully a new standardised inspection

The conditions need to be developed in conjunction with the industry to ensure that they successfully support animal welfare standards on the shop floor rather than increasing the burden of red tape. The conditions should take into account that there are different types of pet stores. Our aquatics only stores will have very different routines and management requirements than that of a full range pet store. Many important conditions for looking after mammals will not apply to aquatics and vice-versa.

A standardised approach to report if the regulations are being standardised makes sense. Again there will be differences in conducting and reporting inspections between aquatics only and full range pet stores.

Long term licences for responsible and reputable retailers makes good sense and will reduce the bureaucratic burden for all involved and allow more time to be spent where it is required. However the criteria for the assessment needs to achievable and reasonable. Again the requirements would be different for an aquatics only retailer to a full range pet retailer. The English legislation recently approved makes it very difficult for an aquatics retailer to reach the maximum rating due to the inclusion of impractical requirements that are not achievable even with the best of intentions.

For example, when selling an aquarium we give all of the necessary advice in order to get it established and then test the water for the customer before they add fish. We have our own self imposed livestock charter where we refuse to sell fish to customers who have not followed our mandatory advice. We have many resources available including advice leaflets, however we are more and more directing people to the reference section on our website which holds far more information than a single leaflet and is more environmentally friendly.

#### Please explain the reasons for your responses.

Some local authorities overcharge for their services and others undercharge. Hopefully the charges will meet in the middle. However I am concerned that the legislation could be onerous on businesses causing a huge increase in costs to meet. If the industry (as the foremost experts on how the trade operates) are involved in the development of the guidelines hopefully these costs can be constrained by requirements being sensible and achievable with a minimum of red tape. If costs are substantial there will be no choice but to pass this on.
