

# Proposed Pet Shop (Licensing) (Scotland) Bill

## Page 1: Introduction

A proposal for a Bill to improve animal welfare by enhancing local authority pet shop licensing powers and updating the licensing system, including in relation to licence conditions, fees and inspections. The consultation runs from 26 March 2018 to 18 June 2018. All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. **Please explain the reasons for your responses.**

Licence Fee setting will be on a cost recovery and therefore cost neutral basis. Time and resource spent with poor performers will be reduced given new licensing framework. Pet shop owners may see increase in cost given review of fees. Pet owners, on the whole, will experience cost neutrality as health and welfare improvements will reduce costly after-care, despite have to pay increased costs to pet shops, reflecting increased licence fees.
