#### Please explain the reasons for your response.

As a holder of a pet shop license in our opinion the conditions are reasonably balanced and do not place undue responsibilities on pet shop owners. However we object to the wildly inconsistent costs between council areas and would like to see a more reasonable price for West Dunbartonshire Council licensing. Furthermore any attempt to raise prices or overly increase the burden placed on our business could result in our decision to surrender our pet shop license. If this were repeated all across Scotland it would undoubtedly lead to an increase in illegal backyard breeding of all species with undoubted consequences to the detriment of animal welfare. If pet shops are to face a greater burden of scrutiny then it is only fair that backyard breeders are dealt with more seriously, as they are a threat to welfare standards and to genuine, license fee paying businesses. Our hope is that any amendments to pet shop licenses are made on the basis that pet shops are a welcome part of retail which are a part of the animal welfare solution, not the problem.
