## **Proposed Disability Commissioner (Scotland) Bill**

### Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

It's clear that what we are doing currently is not enough and recent events have led to disabled people being more vulnerable and less well served. This indicates both a need for change and an urgency too,

There is some concern that the Equality act has resulted in a loss of focus on disability. It's important therefore that this risk is not repeated when setting up the role of commissioner. Therefore we support this being a role focussed on disability ensuring that it covers hidden disabilities as well.

We currently have good legislation in Scotland, however that legislation is frequently breached without any consequences. What we are currently doing is not enough to effect change, hence our support for the commissioner role.

It is therefore crucial that they work with disabled people as well as all relevant organisations such as MACS and the range of disabled peoples organisations who will have detailed knowledge of the issues and collectively can identify the cross cutting themes and issues.

Although the commissioner cannot investigate all breaches of the existing laws that affect disabled people, they should be able to look at areas where there is an argument for wider public interest, rather than an individual one alone.
