Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

If the commissioner is to be for disabled people it should involve disabled people directly and not filter through organisations unless this is the only way of getting feedback.

There are a number of organisations that are funded by public bodies but have no oversight. For example advocacy organisations.

This means that service quality can be poor if not dangerous. There appears to be a tendency to fund third sector organisations to fulfil a statutory duty but not ensure it is of sufficient quality.

Some form of oversight is needed to ensure safety and that public money is being spent wisely.
