Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

I am physically disabled and I am constantly discriminated against. This is from the DWP, NHS and struggle to obtain a job that would take into account my disability.

The comments I often get from staff across the DWP are often very undermining and often talked down to because I am disabled. There should be legislation that people who work in agencies should be taught by disabled people how discrimination affects how they live.

This would have tackled fuel poverty and be more sustainable. Would prefer to be sustainable, but have to deal with agencies who are not sustainable.
