Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

Please explain the reasons for your response.

Being disabled myself, mainly from late teens then late fifties onwards I have been shocked at how little support there is for disabled people especially those with hidden disabilities. I have only been aware over the last eight years that both my young men were on the Autistic Spectrum and as far as I can tell the Autistic Community have been sold down the river for years. So many should and have failed to support that's especially true of the Scottish Parliament where their ongoing answer seems to be report after report with no improvement.

This Bill highlights many of the ongoing failures within the disabled community .

I was bullied , threatened with slander and the whole episode was covered up and swept under the carpet . Parental blame is rife . The only system that works effectively in Scotland is the system that covers up the truth . If you dare complain majority close ranks .

It's easier to prevent than undo years of misdiagnosis and the wrong support leading to Mental Health crisis and PTSD .

Accept the PDA profile of Autism and make sure there is a clear pathway for acceptance and support .Enforce our Education Laws . Again it's a two tier system those who can afford private Lawyers to support their cases .
