Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

The Equality Act 2010 has no teeth it looks like a suggestion only for employers to make reasonable adjustments yet many companies do not. The gov.uk website openly states that an employee can have their employment terminated if there are no adjustments that can be made which makes it too easy for a company to say "we cannot make any adjustments so leave the company". Having a commissioner employees and the general public can turn to to fight in their corner may help give confidence to disabled people to come together and fight for change together.
