Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

The focus on disability discrimination has become diluted, yet due to the number of disabled people it likely affects a larger part of society than any other type of discrimination (though this is just my guess, I don't have figures to back this up)

I can see that you probably have to do it that way in order to not discriminate, but I would like to caution that this may in itself result in dilution of the office holders time and capabilities, and that it might also mean that some sections of the disabled population are more represented than others (for example, people with 'hidden' disabilities, or sensory impairments are often quite capable of articulating their opinions, whereas people with learning disabilities or profound multiple disabilities cannot communicate their needs without significant support, and someone needs to make the effort to seek them out. The degree to which people experience discrimination or exclusion from society also differs, based on the severity of their disability, the availability of support organisations and the degree to which these organisations can influence individual's exclusion
