Introduction

A proposal for a Bill to establish a Disability Commissioner for Scotland

The consultation runs from 12 May 2022 to 3 August 2022

People with disabilities and their carers form a significant proportion of Scotland's population, but there voices are under-represented in the corridors of power. They need a powerful spokesperson to represent in the Scottish Parliament and ensure that their needs are addressed. For many people with additional needs daily living is a sufficient struggle, without also having to fight for their rights, often in a labyrinthine system which is difficult to navigate. A "one stop shop" would be a huge improvement.
